Dear Customer,

Thank you for choosing Blue Arrow Unaccompanied Baggage Services for your shipping. Please read the below information carefully and if you have any questions, please call us at 647 847 3187 (EXT: 1613).

PLEASE NOTE This service is only for unaccompanied baggage, i.e. for people travelling to that destination but do not wish to carry their bags with them. This service is NOT for people wishing to send items to their friends or relatives abroad.

Airlines and Shipping companies do not guarantee specific arrival dates or times. As such we are not liable for delays. If your shipment is URGENT or time sensitive, we can offer you a COURIER service at a different price, but even this service does not guarantee delivery of the shipment within a specified time. The International IATA conditions of carriage will apply, and these can be found on the reverse side of the printed Airway Bill or provided to you on request.

All freight is subject to current security procedures, which may include X – Ray and a physical search of the items. DO NOT put cash or valuables in your shipment. If the freight is locked, a duplicate key must be deposited with us for a security check if required. If your baggage is denied carriage, it will be returned to our office for pickup at additional costs.

Your packing list on the next page is a declaration of what is packed in the suitcase. It will stay in Canada and will not be used for the purpose of customs clearance at destinations. This is just a declaration that you will sign confirming that baggage does not contain items which are not permitted or banned such as EXPLOSIVES, COMPRESSED GASES, OXIDIZING SUBSTANCES, ORGANIC PEROXIDE, CORROSIVES, FLAMMABLE LIQUID AND SOLIDS, FIREARMS, RADIO-ACTIVE MATERIALS, POISONOUS(TOXIC) INFECTIOUS SUBSTANCES AND DRY ICE THAT ARE CONSIDERED HAZARDOUS OR ITEMS PROHIBITED BY THE FOOD AND DRUGS ACT OF CANADA OR ITEMS PROHIBITED BY THE CONTROLLED DRUGS AND SUBSTANCES ACT OF CANADA. It is illegal to send certain items by Air freight. In case of doubt, please speak to our representative.

We do not provide insurance coverage for damage / delay of your shipment. We can arrange insurance for you and the approximate cost is based on 5% of your declared value, based on a minimum of \$75 per shipment in case of total loss of your shipment.

You will need to provide us with one piece of government issued photo ID when handing over your shipment. This may include a valid driver's license OR a passport copy.
